- (a) Enrollment will be limited. Satisfies the upper-level *Skills* requirement. Preference will be given according to date of graduation.
- (b) Recommended Prerequisite: Secured Transactions
- (c) Prerequisite: Constitutional Law
- (d) Prerequisite: Decedents' Estates.
- (e) Prerequisite: Income Tax
- (f) Enrollment will be limited. Satisfies the upper-level *Research/Writing* requirement for those students having completed three (3) semesters in the full-time program or forty-five (45) semester hours in the part-time program. Papers, in final form, are due no later than the last day of the examination period. Preference will be given according to date of graduation of those who have not fulfilled the research requirement.
- (g) Prerequisites for all Legal Clinics are Professional Responsibility and Evidence. Enrollment will be limited. Clinics will meet for 6 hours per week during the first three weeks of the semester for orientation and training; times to be arranged based on student schedules.
- (h) Prerequisite: Evidence
- (i) Enrollment limited to students on Travel Teams; students will be enrolled by Law Registrar.

- (j) Enrollment limited. Students enrolled in an Externship may not be enrolled in more than 16 hours. Students must have completed 60 hours before enrolling in an Externship. Students will meet once a week with the Externship Faculty Member. Secured Transactions is a prerequisite for the Bankruptcy Externship.
 - (k) Students may enroll in the semester they will complete the competition requirements or in the semester they are graduating.
 - (l) Students enroll themselves in the semester they are graduating.
 - (m) Students enroll themselves in the semester they are graduating.

Notes:

- It is the student's responsibility to be familiar with the [Academic Regulations](#) prior to enrolling.
- Students may not repeat the same Externship or the same Clinic. A student may not enroll in both a Clinic and Externship in the same semester or summer session, and may not enroll in more than one Clinic or Externship in any semester or summer session.
- Refer to the **EXAM SCHEDULE** when making course selections. Each student is responsible for enrolling in courses that do not have conflicting exams. Students may not enroll in courses that have conflicting examination schedules unless written approval is obtained from the Associate Dean prior to enrolling. All requests for approval of conflicting exams must be submitted in writing to Dean Romantz prior to enrolling.
- Remember that only eight (8) hours of non-class courses count toward graduation. Non-class courses include Independent Research, Moot Court, Law Review, Advanced Appellate Advocacy, Advanced Trial Advocacy, and any Externship.
- Students enrolling in Independent Research I must submit a completed Research Paper Form **before** enrolling. Research Paper Forms are available in the Registrar's Office, Room 262.
- **Full-time** students **MUST** enroll in at least 12 semester hours and not more than 18 semester hours. **Part-time** students **MUST** enroll in at least 8 semester hours and not more than 11 semester hours. Students wishing to change programs **MUST** submit a written request to the Associate Dean for approval.
- No student with less than a 2.5 cumulative grade point average may enroll in more than 16 credit hours in a semester unless prior approval is obtained by the Associate Dean.

- Required first-year and second-year courses **MUST** be taken in sequence as indicated in the Academic Regulations, Sec. 16.1a./b. The only exception is that part-time second-year students will take Income Tax during the Fall 2011 semester instead of Constitutional Law.
- In addition to our required curriculum, the following elective courses are subjects that have been tested on the Tennessee Bar Examination. These courses will not be offered in the Spring 2012 semester.
