CHECK LIST FOR GRADUATE ADMISSION TO THE UNIVERSITY OF MEMPHIS LOEWENBERG SCHOOL OF MEMPHIS

Students who desire admission to the graduate program of the Loewenberg School of Nursing must:

1. Complete admission to The University of Memphis as a degree-seeking graduate student.

2. Hold a Baccalaureate degree in nursing from an accredited college or institution. Registered Nurse applicants with a baccalaureate degree in a discipline other than nursing are required to complete a 15 credit hour Bridge Program.
3. Have a minimum cumulative grade point average of 2.8 on a 4.0 scale.
4. Provide 3 completed MSN Recommendation forms (available online) from 3 persons qualified to judge the applicant's ability to practice in an advanced role such as nursing supervisors or physicians.
5. Interview with LSON graduate faculty if requested by admission committee
6. Submit current professional resume.
7. Submit a letter of interest from applicant addressed to the Admission Committee which discusses prior professional experience, future career goals, and reasons for pursuing graduate study
8. Submit TOEFL scores - required for applicants who speak English as a second language. The TOEFL scores must be a minimum of 79 (internet based), 213 (computer based), and 550 (written)
9. Students who are transferring from another graduate nursing program must submit a letter of good standing and transcript from the dean/director of the previous nursing program.
10. Complete and submit School of Nursing application for admission to:

Standardized Admission Test

The standardized admission test is successful completion of the NCLEX licensing examination. The Graduate Record Examination (GRE) is not required.

Admission Requirements for BSN Applicants

1. Completion of BSN.
2. An unrestricted registered nursing license to practice in Tennessee

Admission Requirements for RN/MSN Applicants with a BA/BS non-nursing major

1. A BA or BS in a non-nursing major
2. An unrestricted registered nursing license to practice in Tennessee
3. Completion of a 15 credit bridge sequence prescribed by the LSON Associate Dean.
4. RN/MSN graduates will not be awarded the BSN degree.

Note: The Nurse Practice Acts in several states require that nurses hold an earned degree (AAS/BSN in nursing) or a diploma in nursing prior to successful completion of the NCLEX examination in order to obtain a registered nursing license in that state. Generic master's students who licensed via a certificate program and then continued to obtain an MSN as the first nursing degree would not be able to be licensed in those states.
