# Emerging Leaders Scholarship Program

## Requirements and application procedures:

- Minimum high school GPA of 3.0 and minimum ACT of 21/980 SAT.
- Provide documentation of leadership background that should include, but is not limited to: participation in high school extra-curricular activities, involvement in community programs, and other experiences that supported leadership development. **The primary purpose of this application is to demonstrate your background and interest in leadership development.**
- Students must provide one letter of recommendation either from an academic affiliate (principal, counselor, teacher or administrator) or from an individual representing a community agency, organization, religious institution or employer with whom the candidate has been associated.
- Application should also contain answers to the following essay questions. Your answers should not exceed four pages total and should be attached to this application
  - 1.) Why are you interested in the Emerging Leaders program?
  - 2.) What personal values guide your leadership decisions?
  - 3.) What motivates you to be a leader?
  - 4.) If you had the opportunity to change something in your community, what would you change and why?
- Interviews are required and are tentatively scheduled for February or March 2010.

## Covers:

- \$ 5,500 per year (as of September 2009).
- Payable in two disbursements, fall and spring registration periods.

## Renewable Criteria:

- Renewable after completion of year one with 2.75 GPA; after completion of year two with 3.00 GPA.
- Must meet all other program requirements.
- Recipient must enroll as a full-time student (12 Hours) Fall and Spring semesters and complete 24 credit hours annually.
- Recipients must meet the requirements of the program as outlined each Fall semester.
- **Students must live on a leadership learning community floor in Richardson Towers and purchase a meal plan during the first year of the program.**
