SUMMARY OF RESPONSES TO THE 2012 NAAB VTR (Initial Accreditation) (Progress Made Since Submittal of 2012 Annual Report)

Part II (Narrative Report) is the narrative report in which a program responds to the most recent Visiting Team Report (VTR). Responses to 1.4 Conditions Not Yet Met

B. 7 Financial Considerations: Understanding of the fundamentals of building costs, such as acquisition costs, project financing and funding, financial feasibility, operational costs, and construction estimating with an emphasis on life-cycle cost accounting.

2012 Team Assessment: Student work reflects an understanding of construction cost estimating. However, no evidence is provided to show the students' knowledge or understanding of acquisition costs, project financing and funding, financial feasibility, operational costs, and life-cycle cost accounting.

Members of the Department of Architecture faculty have met several times on this issue and the team is continuing to develop ways to ensure this SPC is fully met in the future. For example, in the spring 2013 ARCH 7431 Advanced Professional Practice course, an entire session was devoted to "Financial Considerations" which covered project development, value analysis and life cycle costing. In the fall 2013 semester, the following subjects were covered in the ARCH 6231 Issues in City Building course: financial development incentives including TIFs, TDZs, PILOTs, municipal bond financing, historic and low-income housing tax credits, mortgage interest tax credits, façade improvement grants, low-interest development loan and forgivable business loans. These were in the context of policies that would influence where real estate investment occurs and the impact of incentives on project proformas. Also covered were real estate development proformas including project costs, sources and uses, financing costs, and project revenue/expenses in cash flow statements.

In addition to a variety of readings, a representative from a local real estate development firm lectured on life cycle and operational costs, acquisition costs, project financing, and financial feasibility. This firm, and representatives of other real estate development firms with which the Department has a good relationship, have also been involved in other courses. Discussions are also ongoing with faculty in the City + Regional Planning program (CRP) and the Real Estate Development (RED) program relative to how they could work with the Department to further integrate this content into ARCH 7431 as well as other courses including graduate design studios.

Responses to 1.5 Causes of Concern

From the VTR - The 2012 NAAB visiting team has no cause for concern. The members of the architecture program have spent many years moving toward program accreditation. They have sought and responded to advice from senior educators at other prominent schools as well as from NAAB directors and NAAB visiting teams leading up to this initial accreditation visit. The chair of the architecture program participated as an observer during a NAAB visit at another school the previous year. All of this preparation has greatly benefited the program.

No response necessary.

Changes in Program since last NAAB visit

Effective the fall 2013 semester, the Department of Architecture hired two tenure-track Assistant Professors. Both of these faculty members had previously served as members of our adjunct faculty and one served a year as a full-time visiting faculty member. Both hold a professional B.Arch and post-professional M.Arch degree and have relevant professional experience.

ARCH 6231 Issues in City Building was added to the curriculum and is being taught in the fall semester. The course, taught by a registered architect / certified city planner, is open to students outside the Department of Architecture. A special course, ARCH 7031 Research and Training is being offered to all M.Arch students to better prepare them for the rigors of thesis research and thesis studio.

The Memphis Regional Design Center (MRDC) with which the Department of Architecture has had a close relationship since partnering to create the MRDC will become an official center at the University pending approval of the Tennessee Board of Regents. The new University of Memphis Regional Design Center will be a joint center administered by the Department of Architecture and the Graduate Program in City + Regional Planning. This will further enhance the relationship between the two academic units while providing additional benefits to the Memphis and Mid-South Region and "hands on" experiences for our M.Arch students as well as our undergraduate students.

SECTION G. HUMAN RESOURCE SUMMARY (Architecture Program)

1. Credit Hours Taught

The total number of credit hours in the M.Arch degree is 60. Of these, 15 are electives. In the reporting year all but one of the required courses was taught by a full-time architecture faculty member, the other course was taught by an adjunct professor of architecture. The electives were taught by full time faculty in architecture, city and regional planning, and other academic units. However, this mix may vary from year to year.
