Hooks Institute to Unveil **Two New Civil Rights Websites**

The Hooks Institute has been hard at work producing not one, but two new websites chronicling important events in the civil rights history of the Mid-South. The first site is called Tent City Stories: Telling the Stories of Fayette County, Tennessee. For this project, Daphene McFerren (Director of the Hooks Institute) and Hooks Institute graduate assistants Armanthia Duncan and Michael Blum are working with Dr. Loel Kim of the University of Memphis Department of English to publish an online commemoration of the events surrounding the Fayette County black voter registration drives of the 1950s and '60s. When white land-owners sought to deter voter registration by evicting African American sharecroppers from their farms, blacks offered their own land to the ousted sharecroppers, and massive Tent Cities arose. Tent City Stories is a collection of first-hand accounts of how blacks banded together and endureed, making Fayette County the site of what the New York Times would later call the "longest sustained civil rights protest in the nation."

The second website, entitled A Mapping History of The Civil Rights Movement in West Tennessee, recalls notable civil rights milestones of the Mid-South with a particular focus on education and labor. Dr. Esra Ozdenerol of the University of Memphis Earth Sciences Department has spearheaded the site's technical development. In order to compile the massive amounts of historical data, extensive research and initial content drafting was conducted by Michael Blum, a graduate student in the Department of History, working with History professor, Dr. Aram

RESEARCH WATCH

In 2008, the tragic deaths of two local African American teens in public swimming pools brought new attention to what is now widely recognized as a national trend: minority youth are less likely to know how to swim — and thus at greater risk of drowning.

The 2008 drownings sparked the birth of Make a Splash Mid-South, a community-based organization that provides at-risk children with swimming lessons, encourages minority participation in swimming, and supports local lifeguard training. Since the program's inception, the Hooks Institute has provided funding to support the work of University of Memphis researchers Carol C. Irwin, Ph.D. and Richard L. Irwin, Ed.D., who have conducted two different studies to gather data on the impact of Make a Splash and develop strategies for continual improvement.

Results indicate that Make a Splash Mid-South is an effective approach to addressing this health disparity among minority populations.
