# 2021-22 COVID-19 Guidelines

## Executive Summary

In accordance with the most current [CDC recommendations](#) Campus School has developed COVID guidelines for the 2021-2022 school year.

Key Points for all stakeholders:

- Campus School is implementing a five-day in-person school model that includes traditional classroom activities, recess, community building activities, and afterschool programming.
- In light of local conditions and in accordance with the most recent [CDC recommendations](#), Campus School will begin the school year requiring all University Schools faculty, staff, students, and guests to wear masks while on school grounds regardless of vaccination status.
- Students should bring at least 2 masks (disposable or reusable) to school per day. Appropriate mask wearing procedures will be shared with students and reinforced in school.
- All parents, family members, and visitors should follow the CDC's guidance for mask wearing while on school grounds including during pick up and drop off, meetings, and school events.
- In accordance with the most current [CDC recommendations](#), Campus School will not conduct daily symptom screenings, including temperature checks.
- Routine [screening testing](#) can help to identify cases of COVID-19 in asymptomatic or pre-symptomatic people, and prevent secondary transmission. We will continue to offer optional, in-school COVID-19 testing for the 2021-2022 school year.
- Campus School will utilize best practices to mitigate spread such as social distancing to the extent allowed, frequent handwashing, cleaning and sanitization protocols, quarantine protocols, and isolation of symptomatic students.

Campus School's plan for protecting our students, faculty, and families is a living document that will be monitored and re-evaluated as deemed necessary based on CDC, Shelby County Health Department, State of Tennessee, University of Memphis guidelines and Campus School transmission rates. Parents and stakeholders will be notified of any changes to this policy.

In accordance with the most current [CDC recommendations](#) Campus School has developed the following protocols:

### **Prevention Guidelines**

Campus School is a public school therefore vaccination requirements must comply with State of Tennessee policy. At this time, the state has not required student or staff to receive COVID-19 vaccinations. As such, Campus School cannot require eligible students or staff to be vaccinated. University Schools will not require COVID-19 tests or vaccinations for teachers or students prior to the start of school. While we acknowledge that testing and vaccination are essential tools in the epidemiological response to the pandemic, these practices are solidly in the domain of health professionals, not the school. We will monitor that people inside our schools and office buildings are symptom-free and will strongly encourage all students and staff who are not feeling well to stay at home.

In light of local conditions and in accordance with the most [recent CDC recommendations](#), Campus School will begin the school year requiring all University Schools faculty, staff, students, and guests to wear masks while on school grounds regardless of vaccination status. Students should bring at least 2 masks (disposable or reusable) to school per day. Appropriate mask wearing procedures will be shared with students and reinforced in school.

All parents, family members, and visitors should follow the CDC's guidance for mask wearing while on school grounds including during pick up and drop off, meetings, and school events. Campus School and all related programs will layer multiple [prevention strategies](#) to help slow the spread of the virus that causes COVID-19.

Students must still submit proof of state required immunizations as outlined in the Family Handbook, but this immunization does not include vaccination for COVID-19.

### **Temperature Screenings**

In accordance with the most current [CDC recommendations](#), we strongly encourage parents and guardians to monitor their children for [symptoms of infectious illness](#) at home, including a temperature of 100.4 or greater.

### **Masks**

In accordance with the most [recent CDC recommendations](#), Campus School will require all University Schools faculty, staff, students, and guests to wear masks while on school grounds regardless of vaccination status.

The following will serve as guidelines for mask wearing:

- All students may remove their masks during lunch.

- Students in music and P.E. will remove their masks for instruction when socially distanced in class.
- All faculty, staff, and students should wear well-fitting [cloth masks](#) with two or more layers of tightly woven, breathable fabric, or [disposable masks](#).
- Students should bring at least 2 masks (disposable or reusable) to school per day. The school has a supply of extra masks on hand that may be used when students or staff are without a clean, usable mask.
- School staff will teach and reinforce [consistent and correct](#) use of masks. Faculty, staff, and students should wear masks over the nose and mouth.
- Faculty, staff, and students should store masks properly and for reusable masks, wash them regularly to keep them clean.
- All individuals are encouraged to [remove masks correctly](#) and wash hands with soap and water or use hand sanitizer containing at least 60% alcohol after touching or removing a mask.
- Masks should be stored in a safe location to keep them clean, such as in a pocket or backpack. When reusing a mask after a break, keep the same side should be kept facing out.
- Masks should not be worn during activities that could get masks wet. A wet mask can make it difficult to breathe and may become less effective in preventing the spread of germs (this may include outdoor recess during the hotter months and P.E. class).

### **Hand Sanitizing and Washing**

Every classroom and office will be supplied with hand sanitizer and alcohol wipes. Students will be encouraged to sanitize their hands when entering and exiting class. Students will be encouraged to wash their hands frequently.

### **COVID-19 Testing**

If available, routine [screening testing](#) can help to identify cases of COVID-19 in asymptomatic or pre-symptomatic people, and prevent secondary transmission.

Faculty, staff, or students who display symptoms of infectious illness during the school day will be required to leave school and provide a negative COVID test result before returning to school, at the discretion of the school administration. The school nurse or office coordinator will contact parents if COVID testing is necessary.

### **Symptomatic Children**

Children who become [symptomatic](#) during the school day will be isolated in the designated quarantine zone with a staff member until parents arrive. Parents will be required to pick up their child within 30 minutes of initial contact. Students who are sent home may return to school only with a written release from a physician to return to school.

Campus School will follow UofM and CDC guidelines if an infected person has been in a school building. These guidelines include measures for contact tracing, communications, disinfecting/sanitization, and potential closure of a classroom or school facility.

### **If a Student, Faculty, or Staff Member Tests Positive**

It is imperative to community health that the school leadership be made aware of any student or staff member that has tested positive for COVID-19. All staff and students can be assured of confidentiality and privacy when reporting their positive test results to the school director. The school will follow all current CDC, and health department guidance on what to do when students or staff exhibit symptoms and when a case is suspected/confirmed.

Students or staff who exhibit symptoms will be directed home to self-isolate and seek medical attention, as necessary. Positive or suspected cases will be confirmed with the local Health Department who will assist with developing recommended next steps based on the level of potential exposure.

School administrators will [take action](#) to [isolate](#) people who begin to have symptoms from other children and staff. Designated isolation areas will be used to isolate a sick student or staff member. The school will ensure that isolated children are still under adult supervision. The school will close off areas used by a sick person and will not use these areas until after [cleaning and disinfecting](#) them; this includes surfaces or shared objects in the area, if applicable. Within the first 24 hours after the sick person has been in the space cleaning and disinfecting will occur.

Staff members or students with COVID-19 or with confirmed exposure to someone with COVID-19 should not return to school until they have met CDC's [recommendations to discontinue home isolation](#). Students will not be marked absent if their absence is due to exposure to COVID-19. Once the affected individual has met all the CDC criteria for ending isolation, then no additional testing is needed to return to the facility.

### **Visitors**

All visitors will be required to wear a mask while on school grounds. Non-essential visitors will continue to be minimized in an effort to reduce risk of outside exposure. Any visitor admitted into the school must check in at the front office to request admittance and may be screened for signs of illness or history of exposure. Any visitor exhibiting one or more of the following will not be admitted to the facility:

- Temperature reading of 100.4 or above
- Any [signs of illness](#)
- Known recent exposure

Any requests for in-person academic or research-based observation must be submitted to the director in advance for approval. No observers will be admitted into the building without director approval. Any approved observations must be conducted from a distance of at least 6 feet from all school staff and students at all times. Visitors must follow campus mask policies while on-site. Any visitor diagnosed with COVID-19 should inform the school as soon as possible, [isolate](#), and may not return to the school until [requirements for end of isolation are met](#).

**Social Distancing**

Students will be encouraged to social distance as much as feasibly possible while in the classrooms. Students will receive instruction on social distancing in the classroom, common areas, and the hallway. Outdoor spaces will be maximized as an option for extending the physical learning space of classrooms and to provide children with opportunities for movement.

**Class Structure**

Each individual classroom will remain as a cohesive group. However, students in grades 3-5 will not remain in their homeroom class all day. These students will switch classes to receive instruction in the different content areas. All students will also participate in support classes.

**Recess**

Students will be allowed to play with students in their homeroom as well as students in their grade level. During the hotter months, accommodations to the mask policy may be made during recess as outlined above, and in accordance with CDC guidelines. It is important to make sure that all children and staff wash their hands for a minimum of 20 seconds using soap and water after returning from the playground to prevent any spread of germs. **Classroom Materials**

The Center for Disease Control (CDC) provides classrooms with considerations for both hard and soft surfaces. When selecting materials for use in the classroom, Campus School will apply the “less is more” concept to optimize use of essential learning materials while minimizing time spent on cleaning multiple materials. In addition to the “less is more” concept, we will discourage group sharing of materials. Students are required to have their own classroom supplies. Each child will have a designated set of frequently used materials such as scissors, crayons, pencils, and glue. Teachers will carefully consider what type of materials are easily sanitized vs. those that require more cleaning effort and attention, including but not limited to area rugs, pillows, stuffed toy animals, and puppets. Teachers are encouraged to replace soft covered, porous materials with easy-to-clean surfaces.

**Cleaning, Sanitization, and ventilation of Campus School Facility**

All cleaning and disinfecting procedures will follow [CDC guidelines](#) for recommended practices. Indoor spaces will undergo sanitization treatment using the [Clorox Total 360 Electrostatic Sprayer System](#) each night.

Deep cleaning will occur between student departure and arrival and cleaning will occur consistently throughout the day by assigned facilities staff members who have been trained in preventative disinfectant measures. Campus School teachers will have access to CDC-approved disinfectant and hand sanitizer and frequent hand washing will be required.

**Communications**

Our goal is to provide transparent communication to all stakeholders of the Campus School Community. To assist in clear, transparent communication we ask our school community to support the following:

- Follow this communication chain for questions or concerns: 1) First, contact the homeroom teacher or teacher of record 2) If the issue is not resolved, contact the assistant director 3) If further resolution is needed, contact the school director.
- Check your email regularly for updates. If you do not receive school emails, contact the school administration.
- Contact your student's teacher(s) when you have questions about their academic progress or need additional support for assignments, strategies, or clarity around content. If your student is struggling, please let your teacher know so they can provide appropriate in-time supports.
- Contact your school director when you have questions about school operations, COVID-19 strategies, or need to report a potential exposure.

### **Student Support**

- Communicate with your school counselor and your child's teacher if you need additional supports or referrals to support your child's academic, social, and emotional needs during this time of transition back into in-person learning.

### **Community Building Activities, Before and After School Programs, CSPN Events**

- Campus School will return to in-person community building events, Family Gatherings, Award Assemblies, etc. All participants, including faculty, staff, students, parents, family members, and other guests, will be required to wear a mask to these close quarter events for the sake of our school community, regardless of vaccination status.

### **Additional Safety Recommendations**

- Parents and visitors may enter the school for scheduled meetings and events and will be required to adhere to University policies related to mask wearing and social distancing.
- Parents and students should be prepared to drop off and pick up students at assigned locations and times. No students should arrive or be dropped off prior to 7:30am.
