The 99 credit hour program is based on entry into the program with a master's degree in counseling, psychology, or a similar mental health training program. The 99 hour program can be completed in 4 years (includes predoctoral internship year). Students who completed courses in their master's programs that substantially overlap with those required for the doctoral program (including scientific foundation areas of psychology, e.g., social, biological, cognitive) may petition to waive those courses, allowing more time for elective courses. Course waiver requests are considered by the full Counseling Psychology faculty during the student's first semester of enrollment. Faculty consider the extent to which the prior coursework addresses the content area. Waiving courses does not decrease the total number of hours required for the doctoral program. Students entering with some graduate courses toward a master's degree, but who have not earned a master's degree can expect to be enrolled an additional 1 to 2 years.

Amounts are shown for the first year in the program, based on 12 credits per fall and spring semesters and 9 credits for summer semester. Funding packages include 9-12 credit tuition waiver for both in-state and out-of-state students and a stipend for a 20-hour graduate assistantship (Fall/Spring). Stipends generally range from \$750 - \$1,000/month. Assistantships within the Department also provide funding for student travel to conferences. Students are permitted to enroll in part-time hours only when on their pre-doctoral clinical internship or when all program requirements other than the dissertation have been met. Students are charged the in-state tuition rate (currently \$521/semester hour) for internship credits regardless of state of residence at the time these credits are being completed.
