The three-hundred-and-ninety-eighth meeting of the University of Memphis Faculty Senate was held Tuesday, March, 27, 2012, in the Senate Chambers, Room 261 of the University Center.

3.27.12.01 Call to Order

The meeting was called to order at 2:45 p.m. with a quorum present.

3.27.12.02 Approval of Agenda

3.27.12.03 Approval of Minutes

3.27.12.04 Memorial: Dr. Francis A. Gabor

The following memorial was presented by Senator R. Kozma, Department of Mathematical Sciences to mark the recent passing of our longtime colleague Dr. Francis A. Gabor of the Cecil C. Humphreys School of Law. Professor Gabor was a Holocaust survivor who came from his native Budapest to the United States in 1968. In addition to receiving his first law degree in Budapest, he received an LL.M. from the University of California, Berkeley School of Law, and a J.D. degree from Tulane. He was awarded the Fulbright Hays Fellowship and Awards in 1981-82, 1990-91, and 1995-1996. Professor Gabor was a Visiting Professor at the Central European University in Budapest for more than twenty years, and taught summer classes on Transnational Law at the Loyola, Cardozo, and McGeorge Summer Law Programs in Budapest and Vienna. Francis Gabor was a compassionate person. Professor Gabor joined the law school faculty in 1976.

3.27.12.05 Invited Guests: Student Government Association

President Tyler H. DeWitt, Rachel Goodwin (Vice President) and Ricarrdo Hicks (Speaker of the Senate) of the 2011-12 Student Government Association (SGA) Executive Officers These students first aired concerns about the campus's lack of signage and other material evidence of its identity as the U of M. They would like to see more bulletin boards and kiosks to keep the students aware of SGA activities. In particular, they believe it is vital to raise awareness and build more support for our school's athletic program. Our guests feel strongly that we should do more as faculty to raise awareness of Tiger games by announcing them in class and setting a good example by wearing blue or preferably U of M shirts when we teach. This raised some eyebrows. More substantively and compelling, our visitors voiced concern about required courses not being offered often enough, the lack of summer courses, and academic advisors' frequent failure to notice such problems. Our guests responded positively when the Faculty Senate (FS) suggested they could address this by asking President Raines to put more discretionary funds into academics. R. Green proposed a committee be formed where FS and SGA could exchange perspectives and work toward addressing common concerns.

3.27.12.06 President's Report

1. <u>Meeting with President Raines (March 1)</u>: The administration has no problems with our Faculty Policies Committee's response to the new faculty categories. Our committee asks that a line be added to make clear that Lecturer and Senior Lecturer appointments at the U of M are

"for Lambuth faculty only." They also proposed that these positions will be in effect only 2 years before being reviewed for possible continuation; however, they have since accepted the 3 year window the Provost prefers. The Executive Committee (EC) will bring this proposal to the FS for a vote next week.

2. Faculty Lounge Update: We have been offered a room on the second floor of the Lane Rawlins Service Center, which houses the University Bookstore and above it a bank, printing center, and until recently Lifeblood. Faculty could gather there for meals purchased on a subscription basis, but alcoholic beverages could not be served. It is possible, too, that a deal could be brokered with the Wilson Group that runs the Holiday Inn on Central at Deloach for a designated space with long tables (such as they had at the old Wolf River Society), meals, and parking. Alcohol could be served. The most attractive possibility would be to use the Day Foundation mansion on Central at Highland. The EC agreed to survey the faculty as to their interest in any or all of these options. The results will be sent to the 2012-13 Faculty Senate along with the EC's recommendation that this matter be taken up and pushed forward. 3. Faculty Ombudsperson Selection Process: We have three candidates: Wade M. Jackson (Management Info Systems), Brad S. McAdon (English), and Lawrence A. Pivnick (Law). The ombudsperson selection committee has been constituted as follows: Selected by the FS are committee chair Cedar Nordbye (Art), James M. Lukawitz (Accountancy), and Cynthia G. Tucker (English); and selected by the administration, Robert G. Blanton III (Director of Int'l Studies in A&S), Deborah J. Hochstein (Associate Dean for. Academic Affairs and Administration, Herff College of Engineering); and Vivian G. Morris (Ass't Dean, College of Education, Health and Human Sciences).

4. <u>Academic Integrity Policy Committee (Faculty Handbook, Chapter 5)</u>: A call has gone out for nominations for this committee.

5. <u>Tenure & Promotion Policy and Survey Results</u>: President Raines is not excited about the results of the Tenure and Promotion (T & P) survey and says that the Faculty Handbook will have to be left the way it is for right now. Many departments have approved rules specific to their constituencies. The EC is meanwhile considering sending an old proposal to the Faculty Policies Committee to see how well that would fix the T & P problem.

3.27.12.07 Committee Reports

1. <u>Library Policies Committee</u>: Representing the Library Policies Committee, D. Matthews (Communication) came prepared to present this motion.

Before it was brought to a vote, D. Matthews laid out the rationale for urging administration to give the highest priority to funding the University Libraries. In doing so, he provided the following statistics gleaned from the Library Survey to which 20% of the faculty responded.

•75% of respondents were tenured track or tenured faculty

- •91% of respondents use the library anywhere from sometimes to frequently
- •58% of respondents have to get things they want and need somewhere else.

•3 most typical work-around methods: 1) borrow from friend or collogue; 2) use former user ids and passwords at previous institutions; 3) contact the source directly for a copy.

•71% of the faculty spend more personal funds for the resources they need as graduate advisors than faculty who do not advise graduate students.

The motion was tabled until the next meeting.
