The four-hundred-and-fifty sixth meeting of the University of Memphis Faculty Senate was held Tuesday, October 2, 2018, in Senate Chambers of the University Center, room 261.

10.02.18.01 Call to Order

The meeting was called to order at 2:40 p.m. with a quorum present.

10.02.18.02 Approval of Agenda

The agenda was approved as written.

10.02.18.03 Approval of Minutes

The minutes for September 4, 2018, were approved as written.

10.02.18.04 President's Report

1. Southern Association of Colleges & Schools Commission on Colleges (SACSCOC).

President Kurtz reported that the SACSCOC's accreditation is one part of the assessment. Dr. Lori A. Stallings, College of Communication and Fine Arts, has agreed to serve as his designee to the General Education subcommittee as she has more expertise in this area.

2. University Undergraduate Council. President Kurtz reported that Dr. Terra L. Smith, School of Health Studies, has agreed to serve as his designee on the University Undergraduate Council (UUC). He thanked Senator Marchetta for his past service on this council as his designee.

3. Salary Database Update. President Kurtz reported that the UofM's most current salary information will be provided to TN Tech University in October per his meeting with Mr. Raajkumar (Raaj) Kurapati, Chief Financial Officer, Division of Business and Finance.

4. Administrative Efficiency Review. President Kurtz reported that Mr. Bruce Harber will be chairing the panel on Administrative Efficiency Review, which will include the Faculty Senate (FS) President and five others. He will keep the FS informed of any progress made by the panel. Also, a process a process improvement project team has completed the staff hiring process.

5. Risk Assessments. President Kurtz reported that the Deans and department chairs have been informed about the University Risk Assessments and this review will be a bottom-up effort.

6. CommuniTech Research Park. President Kurtz reported on the initiative on community outreach, called CommuniTech Research Park, under Executive VP Research Innovation, VP Research, Dr. Jasbir Dhaliwal's leadership. The first version of this will take place in the old City of Memphis library building on Highland Street. Sidebar: University President Rudd stated that the project is privately funded and an RFP will go out soon. The UofM has future plans to tear down University-owned housing to build a new building. Currently seven companies are buying in on this initiative. The cost to the UofM should be around \$250,000. The various companies are required to hire UofM faculty for any external consulting and if it is a manufacturing entity, the business must employ UofM Students (undergraduate and graduate).

7. University of Memphis Research Council (UMRC). President Kurtz reported that Dr. Jasbir Dhaliwal wants to create a university research council. President Kurtz stated that the Senate will work to fill three positions on the council by October. Members to serve two-year terms,

with staggering rotations. President Kurtz to meet with Senator Waldron, chair of the Senate's Research Policies Committee, regarding the Council.

10.02.18.05 Executive Committee

President Kurtz provided a brief statement to the Senate regarding the motion, Family Friendly Campus Committee Final Report and Executive Summary. The final report was distributed to Senators prior to the meeting. Senator Banning made a motion to accept the final report, voting on the motion was delayed until after Dr. Strong's report. President Kurtz yielded the floor to Dr. Genae D. Strong, co-chair of the Family Friendly Campus Committee to present the final report Family Friendly Campus Committee Final Report and Executive Summary. NOTE: Dr. Carolyn Ransford Kaldon, co-chair of the Family Friendly Campus Committee was in attendance at the invitation of President Kurtz. Senator Elizabeth (Beth) Benton Meisinger, a member of the committee, was recognized by President Kurtz.

Dr. Strong gave background research information on the committee and its final report including an internal assessment of our campus and our peers. The key issues of childcare, early childhood education, and lactation surfaced after the committee conducted a campus-wide survey. The committee's recommendations are reflected in the Executive Summary of the final report. At the conclusion of her report, Dr. Strong opened the floor for questions.

President Kurtz reintroduced Senator Banning's motion: Move that the Faculty Senate accept the ad hoc Family Friendly Campus Committee Final Report as written. At this point in the meeting questions was raised by some senators. Sidebar: University President Rudd informed the Senate that the university had received donor support of \$9M for an early infant childhood building. Also, certain legal issues must go before the local school board, Shelby County Schools (SCS).

President Kurtz again put before the body the motion: Move that the Faculty Senate accept the ad hoc Family Friendly Campus Committee final Report.

Adopted by voice vote, with 1 nay on October 2, 2018.

10.02.18.06 Report of Committee on Committees

President Kurtz yielded the floor to Senator Travis. Senator Travis on behalf of Committee on Committees chair, Senator Dapremont, asked the Senate to accept the nominations as a slate with an up or down vote for the following Faculty Senate representatives and University committees. As a point of information, Senate proxy, Dr. Lynda Feenaughty (Communication Sciences and Disorders), stated that Shaum P. Bhagat's name be removed from the list of nominees because he is no longer employed by the University. The body agreed. President Kurtz, with the removal of Bhagat's name, restated the motion: Move that the Faculty Senate accept the nominations as a slate with an up or down vote for the following Faculty Senate representatives and University committees:

Ongoing Major Projects

- Information Security Awareness Training

Why Security is Important

The University possesses different types of data and is subject to statutory requirements:

- Personal information (students, parents, employees, alumni; tax records, health records)
- Research data (intellectual property, non-disclosure agreements, data use agreements)
- Statutory requirements (FERPA, GLBA, HIPAA, TN Data Breach Notification Law)


Failure to mitigate security threats poses financial and reputational risk to the University.

The Risks of Not Acting

- Data Breach – the estimated cost of remediating a single breached record is \$166. The cost to remediate all current faculty, staff and students would **exceed \$4 million** and insurance may not cover total cost. Costs for remediating all current and former f/s/s would be significantly higher.
- FERPA violations – a compromised password could lead to inappropriate access to or modification of a student record. Violations could lead to fines or loss in federal student aid funding from Department of Education (**> \$100 million**)
- Students – a compromised account could lead to modification of student grades in eCourseware or Banner, or inappropriate communication, such as changes to assignments, cancelling of classes or schedule modifications.
- Research – a compromised password could lead to theft or destruction of research or intellectual property, inappropriate modifications to grant or effort reporting and other potential violations that could effect receipt of current or future grant funding (**> \$30 million**).
- Library Resources – attackers routinely compromise accounts at Universities to access journals and other databases. Failure to control access properly could lead to loss of access to services or litigation.

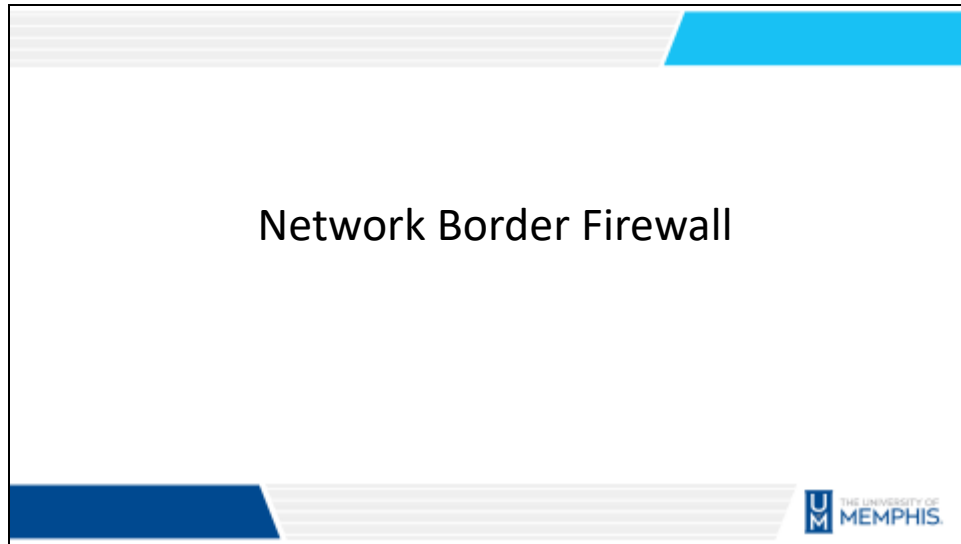


Data breach example - Based on $\$166 * 26,000$ active records. Compromise of all records in Banner would be much worse.

FERPA violation example - Based on IPEDS data from <https://nces.ed.gov/collegenavigator/?id=220862#netprc>. Added Pell Grant aid to Federal Student loan funding as a conservative estimate.

Research example - Based on UofM financial statement from FY17

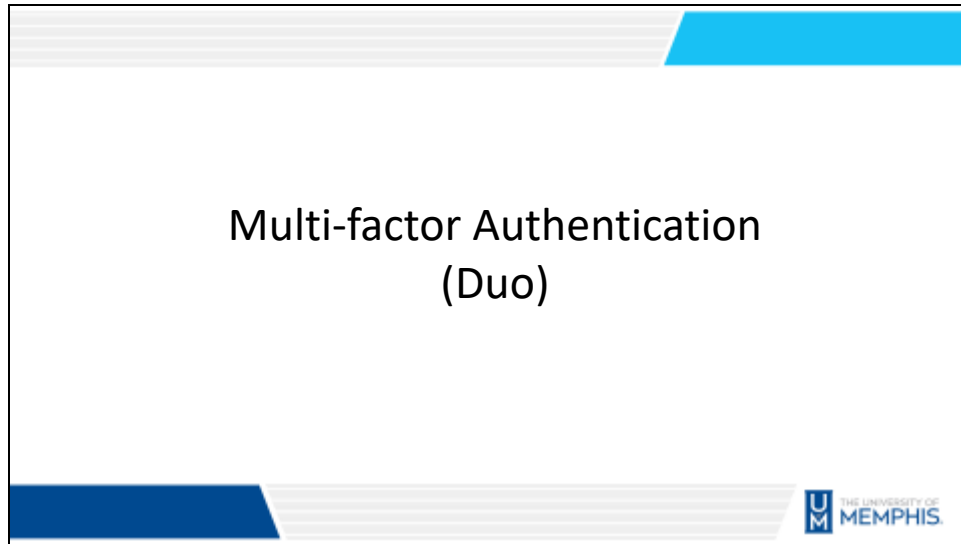

Network Border Firewall

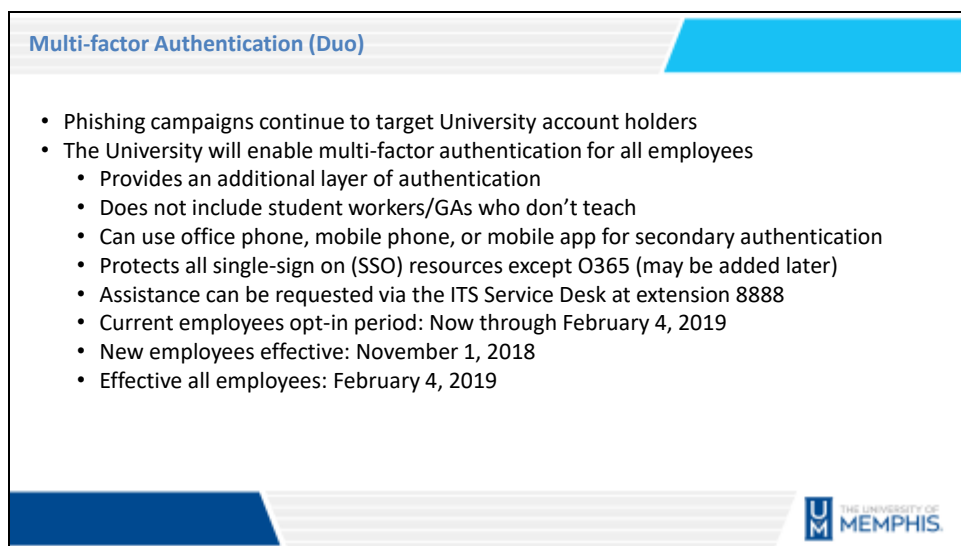
- The University's network border currently allows most network traffic to automatically pass through our firewall and connect directly to devices throughout the infrastructure (e.g., desktops, IoT devices, printers, etc.)
- ITS plans to block, by default, all *external incoming connections* to the University network
 - Most individuals will not be impacted by this change because they use our network to initiate *internal outgoing connections*
 - VPN can still be used to connect to remote desktop
 - Exceptions will be allowed for legitimate traffic (e.g., University web sites, research and teaching activities, etc.)
 - Exceptions can be requested via the ITS Service Desk at extension 8888
 - Effective November 12, 2018

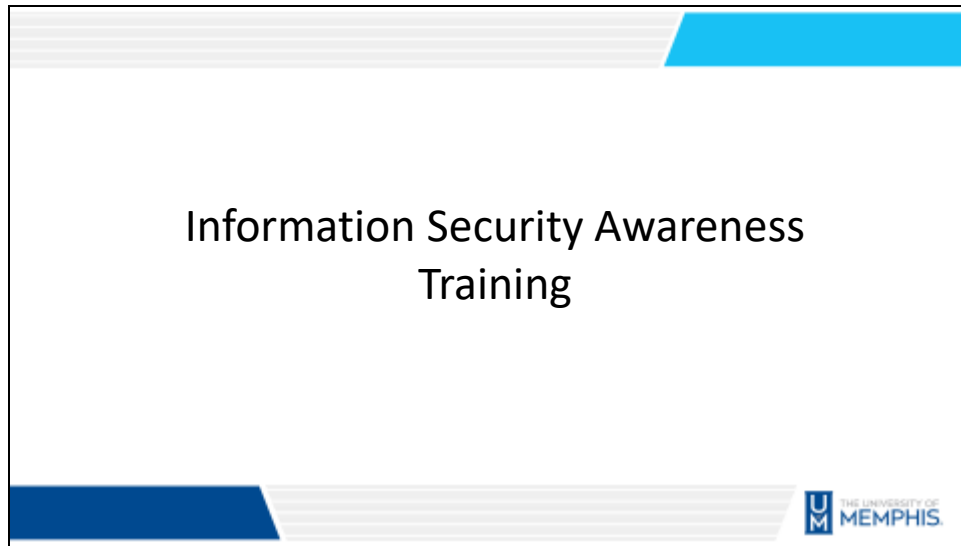

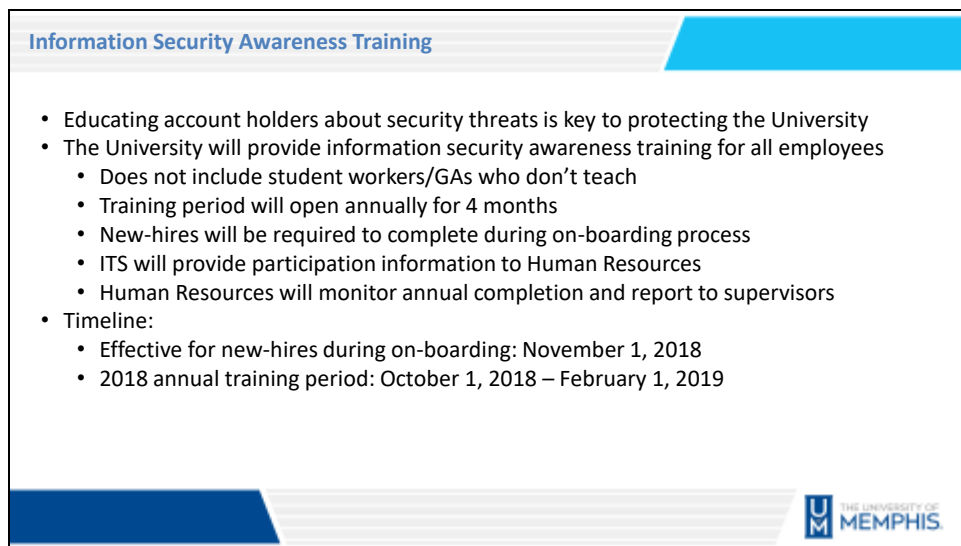
