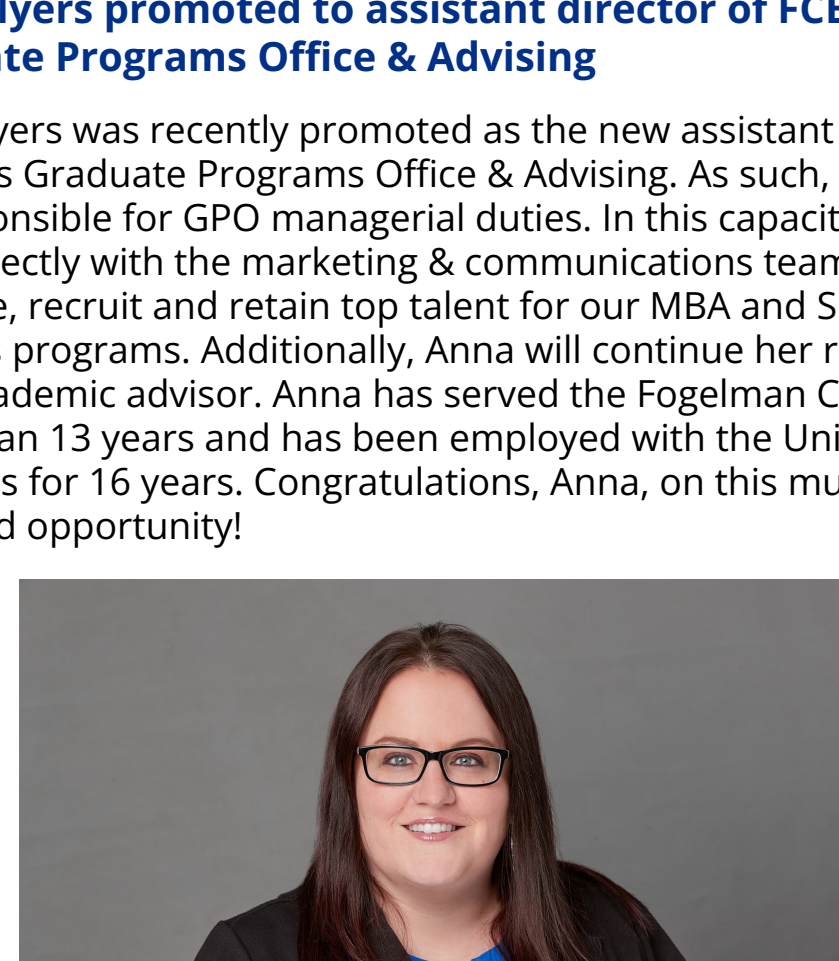


### Dr. Hannah Smith Antinozzi named associate editor of the *Journal of Forensic Accounting Research*

### FCBE faculty members secured CoRS Grants

Dr. Ganga Urumutta Hewage, assistant professor in the Department of Marketing & Supply Chain Management, recently won a \$2,500 grant from the Communities of Research Scholars (CoRS), a part of the UofM Division of Research & Innovation, for her project named "Enabling consumer self-discovery using GenAI to make better pre-consumption decisions." Dr. Yuan Zhang, assistant professor in the Department of Management Information Systems, is also a researcher investigator for this project. Further, Dr. Zhang won another \$2,500 of the same grant for the project named "Unveiling the cognitive and social dynamics of memes." Dr. Hewage will serve as an investigator for Dr. Zhang's team.

Dr. Susy Jaramillo, assistant professor in the Department of Marketing & Supply Chain Management, was awarded a \$5,000 CoRS grant for the second time. The grant will support the project "Evaluating the Effectiveness of Distracted Driving Prevention Advertisements on Young Drivers Using Eye-Tracking Technology." CoRS aims to promote cross-disciplinary collaborations across the University of Memphis and support researchers in finding external funding opportunities. Last year, Dr. Jaramillo's team received a grant of \$2,500. Dr. Jaramillo is the principal investigator on this year's project, and her team includes Dr. Subhash Jha, co-investigator and associate professor in the Department of Marketing & Supply Chain Management, Dr. Brandon Booth, assistant professor in the Department of Computer Science, and Marketing Ph.D. candidate, Casey Waldsmith.

### Marketing Ph.D. candidate Della Garner published as first author in *Psychology & Marketing*

Della Garner, a Marketing doctoral candidate, was published as first author for a paper titled "Good morning, sunshine: How time-of-day complaint submittal can affect customer satisfaction with company response time" in the journal of *Psychology & Marketing*. She co-authored the paper with Dr. Subhash Jha, associate professor in the Department of Marketing & Supply Chain Management, and Jennifer Tatara, former FCBE Ph.D. student. In this research, the authors argue that the time of the day when consumers submit complaints to companies impacts their satisfaction. Specifically, the same company response time will be perceived as more satisfying in the morning than when received in the afternoon. ### MIS professors awarded research contracts from the U.S. Department of Homeland Security

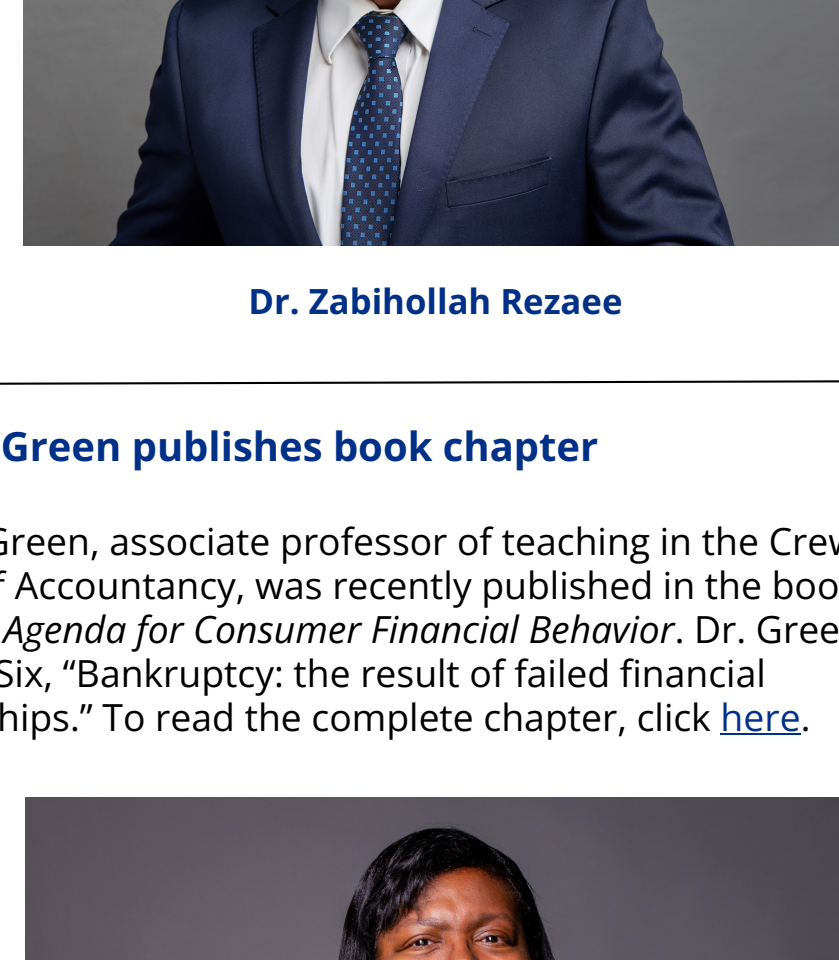
