- Analyze the profitability of alternative investment options and make recommendation of likely investment outcomes

CAREER OPPORTUNITIES

This concentration will provide students with basic problem-solving and analytical tools necessary to be successful in banking, savings institutions, credit unions, securities firms and investment banks, mutual funds management, managing insurance services firms and finance companies. Banking and Financial services is a rigorous and highly respected field of study that prepares students for career options including VP of Commercial Lending, Bank Manager, Investment Banker, Financial Analyst, Securities Trader, Portfolio Manager, Bank Regulator and Financial Executive. Future employment opportunities in financial services areas are expected to grow at a faster than average rate for business professionals.
