



## 2024 - 2025 Federal Unsubsidized Loan Only Certification Form (UNSB)

### INSTRUCTIONS:

Dependent students may be eligible to receive a limited amount of Federal Direct Unsubsidized loan without providing parent information on the FAFSA in the following circumstances:

- If your parents will not provide any financial support and refuse to provide their information on the FAFSA
- **NOTE:** Providing parent financial information on the FAFSA is needed to calculate the student's eligibility for most types of Federal Student Financial Aid. It does not obligate the parent to assist with paying educational expenses in any other way."

However, if you have an unusual circumstance that prevents you from contacting or obtaining your parents' information, you are encouraged to discuss the circumstance with the Office of Student Financial Aid & Scholarships to determine if there are other options or if a dependency override may be possible.

Otherwise, students applying for unsubsidized loans by completing a 2024-25 FAFSA without parental data are only eligible to borrow the base loan limits below, and do not qualify for the additional unsubsidized which is available to independent students and dependent students whose parents are unable to borrow a Federal PLUS Loan. There is **no eligibility for Federal Pell grant or other need-based federal financial aid**. Half-time enrollment (at least 6 credits) is a requirement for a loan disbursement.

#### Academic Year Federal Unsubsidized Loan Limits for Dependent students without Parent FAFSA Data:

Grade Level 1 (Freshman)	\$5,500
Grade Level 2 (Sophomore)	\$6,500
