
Ted Prince


COO, Tiger Cool Express

Mr. Theodore Prince is a co-founder and Chief Operating Officer of Tiger Cool Express LLC, a new venture dedicated to rail intermodal transportation of temperature-controlled freight. The company's focus is the transportation of perishables – primarily fresh produce – using rail intermodal service. The service will represent a lower-cost, more reliable and environmentally-friendly alternative to long-haul truck transportation.

Mr. Prince has spent his career of over 35 years in the transportation industry. He was formerly Principal, T. Prince & Associates, LLC, which provided consulting services for a wide variety of surface freight transportation stakeholders.

Previous transportation experience includes President, Consolidated Chassis Management, LLC, which was formed to develop and own chassis pools. Prior to that, he was Vice President of





Mr. Prince has extensive experience in the information technology sector – as both a user and provider. He spent five years as Senior Vice President for Optimization Alternatives Limited, which developed and deployed large-scale control and decision support systems that manage the day-to-day operations of major international railroads.

Mr. Prince is a graduate of the Wharton School of the University of Pennsylvania, which awarded him a Bachelor of Science in Economics. He also received his Master of Science in Transportation from the University of Pennsylvania Graduate School of Engineering and Applied Sciences in 1990. His thesis, Double Stack Transportation as a Means to Domestic Containerization, served as a business plan to increase domestic business by 300% in two years.

He has been invited to speak about intermodal issues throughout the world and is a frequent lecturer at universities. He has also served on the Business Advisory Council for Northwestern University's Transportation Center and the Global Maritime and Transportation School (GMATS) at the United States Merchant Marine Academy.

A firm believer in public-private partnerships, Mr. Prince has participated in numerous advisory roles for the public sector. He was twice appointed by the US Secretary of Transportation to the Maritime Transportation System National Advisory Council (MTSNAC) and served as Intermodal Vice Chairman for four years.


Stephanie Ivey
