FOOTNOTES

¹ Section 11 of 1L courses will meet in-person in odd weeks, while Section 12 will meet in-person in even weeks. Students should refer to your professors' syllabi for more information.

² Occasional Remote Attendance may be required: Due to social distancing requirements, student may be assigned to groups and required to attend one or more specified classes remotely (e.g., Zoom) to avoid exceeding capacity.

³ 50% Alternating In-Person/Remote Attendance: Due to social distancing requirements, seating capacity is significantly less than current course enrollment. Students will be assigned to groups and will alternate between attending in-person and attending remotely (e.g., via Zoom).

⁴ Appellate Advocacy (Course 309) is a simulation course, but does not have nor is a permit required. Students will meet twice weekly; once as one large group and once divided into small groups.

⁵ §12 of Trial Advocacy will have an online component in addition to the classroom meeting on Fridays, 10:00-11:50 a.m.

⁶ Tax Lawyer (Course 723) is a simulation course, but does not have nor is a permit required.
