1	<b>Self-Scheduled within a Designated 24-hour Period &amp; Timed (Short Window):</b> Students may self-schedule the exam any time during the 24-hour period beginning at the exam's current date/time (e.g., an exam scheduled for 9 a.m. on December 1 can be taken anytime between 9 a.m. on December 1 and 8:59 a.m. on December 2) and will be given a short window for taking the exam (e.g., students must return their answer within 3 hours of accessing the exam materials). 2	<b>Self-Scheduled within the Exam Period &amp; Timed (Short Window):</b> Students may self-schedule the exam any time during the exam period and will be given a short window for taking the exam (e.g., students must return their answer within 3 hours of accessing the exam materials). Exam materials will be available beginning November 30 at 9 a.m. All exam answers must be submitted by December 11 at 4:30 p.m., regardless of when the student first accessed the exam materials.
3	<b>Self-Scheduled within Exam Period &amp; Timed (24-Hour Window):</b> Students will be allowed to self-schedule the exam any time during the exam period and will have 24 hours after accessing the exam materials to return their answer. Exam materials will be available beginning November 30 at 9 a.m. All exam answers must be submitted by December 11 at 4:30 p.m., regardless of when the student first accessed the exam materials.
