<p>Friday, July 9 – Saturday, July 31</p>	<p><b>Installment Payment Plan (IPP)</b> available to sign-up on <a href="#">TigerXpress</a>. An initial down payment of 10% of the remaining balance of tuition and fees is required and the \$25 non-refundable enrollment fee will automatically be calculated in the total IPP plan amount. <b>There is a non-refundable enrollment fee of \$50.00 beginning August 1.</b></p>
<p>Monday, August 2 – Friday, August 13</p>	<p>BAPP (Bookstore Advance Payment Plan)</p>
<p>Monday, August 9</p>	<p>Fee Payment Deadline (4:30 p.m.) for students who register through August 9, 2021.</p> <p>PLEASE NOTE: If you decide to withdraw completely from the University, your courses should be dropped promptly per the Fee Adjustment/Refund Deadlines for each term to avoid owing fees.</p> <p>TigerXpress will be unavailable after 4:30 p.m.</p> <p>Students who wish to re-register for courses with remaining seat availability may do so during *Late Registration and will be assessed a \$100 Late Registration Fee.</p>
<p>Friday, August 13</p>	<p>Deadline to sign up for eRefunds (direct deposit) on TigerXpress for processing excess financial aid/scholarship refunds as available for the initial direct deposit.</p> <p>NOTE: Students who miss this deadline should still sign up in preparation for subsequent disbursements.</p> <p>Financial Aid Disbursement for Fall - Checks will be sent to the Post Office for mailing</p>
