

# Family Law



## What is Family Law?

Family lawyers assist clients with all aspects of the law that relates to domestic relationships. Family law encompasses processes of marriage, divorce, wills, custody disputes, prenuptial agreements, adoption and guardianship, alimony, annulments, surrogacy, and paternity. Family lawyers may also handle cases of domestic violence, child abuse, child neglect, and juvenile delinquency ([Babb et al](#)). Primarily, family lawyers assist with legal questions related to establishing, maintaining, and terminating or reorganizing family relationships ([Katz](#)).

Family lawyers should be familiar with many other types of law that frequently intersect with family law cases, including tort law, contract law, property law, tax law, immigration law, welfare law, bankruptcy law, and housing law ([Hasday](#)). Family lawyers frequently work on contracts and out of court mediation, but also occasionally handle litigation. Some family lawyers specialize in divorce, domestic violence, or adoption, but most family lawyers handle a wide variety of cases ([Babb et al](#)).

Family lawyers primarily deal with state laws, as federal law rarely interferes in domestic relationships. Exceptions include a few Supreme Court cases, such as *Roe v. Wade* which limited governmental regulation of abortions, *Loving v. Virginia*, which struck down state laws that banned interracial marriages, and *Obergefell v. Hodges* which requires all states to grant marriage licenses to same sex couples. State family law regulations vary widely. For example, some states follow the common law principle of dividing property between parties in a divorce based on who each piece of property legally belongs to, but some states follow the community property principle which views all property acquired during a marriage the joint property of the couple ([Smith](#)).

Family law has changed significantly in the last seventy years as child protective services have become a crucial part of the American social infrastructure and as the ways Americans understand individual rights has changed ([Katz](#)). Because family law directly impacts how family relationships are defined, family law impacts how Americans understand gender, race, class, age, and sexual orientation ([Hasday](#)).
