FOOTNOTES

Orientations for each of the offered Clinics will be scheduled for the first three-to-four weeks of the semester according to a schedule to be determined by the Director of each Clinic after conferring with enrolled students. The Clinic orientation schedule will be communicated to enrolled students in advance of the semester's start.

²In addition to the weekly class session, Mediation Clinic students must commit to participate in mandatory, full-day orientation sessions to be scheduled on the first two Saturdays of the spring semester. Each Mediation Clinic student will be required to pay a fee of \$100 to cover costs related to the Rule 31 training offered as part of the course curriculum. The Tennessee Alternative Dispute Resolution Commission also charges at the time of application an additional fee of \$100.

³Students who have prevously taken a fall or spring Clinic course are eligible to enroll as an Advanced Clinic student in that same clinic. If students have questions, please see the Professor who directs and teaches the base Clinic course.

⁴Courses require a permit. **Clinics:** The supervising professor will notify the Registrar's office to issue the permit. The student will be notified by the Registrar's office to register for the course. **Externships:** Prof. Schaffzin will notify the Registrar's office to issue the permit. **Moot Court teams & Board member credit:** Prof. Kritchevsky or Chief Justice will notify the Registrar's office to issue the permit. **Law Review credit:** Prof. Allen or Editor-in-Chief will notify the Registrar's office to issue a permit. **Research (Course 711):** Must have approved from Dean Wilson; she will notify the Registrar's office to issue a permit.

During the week of November 9-13, students may enroll in Seminars and Simulation courses without a permit. After Friday, November 13 at 4:30p, students will need to request a permit for an open seat in these courses.

⁶Full capacity, high demand courses will have a waitlist and be permitted after November 13. A student who wants to be added to a waitlist should email lawregistrar@memphis.edu. If a seat becomes available, students will be contacted and offered a seat in the order their request was made. Students filling an opening will be provided a permit.
