1	<b>Self-Scheduled within a Designated 24-hour Period &amp; Timed (Short Window):</b> Students may self-schedule the exam any time during the 24-hour period beginning at the exam's current date/time (e.g., an exam scheduled for 9 a.m. on April 26 1 can be taken anytime between 9 a.m. on December 1 and 8:59 a.m. on December 2) and will be given a short window for taking the exam (e.g., students must return their answer within 3 hours of accessing the exam materials). All exam answers must be submitted by the end of the 24-hour period, regardless of when the student first accessed the exam materials. Click <a href="#">here</a> to see exam schedule.
2	<b>Self-Scheduled within the Exam Period &amp; Timed (Short Window):</b> Students may self-schedule the exam any time during the exam period and will be given a short window for taking the exam (e.g., students must return their answer within 3 hours of accessing the exam materials). Exam materials will be available beginning April 26 at 9 a.m. All exam answers must be submitted by May 7 at 4:30 p.m., regardless of when the student first accessed the exam materials.
3	<b>Scheduled 24-Hour Take-home:</b> Students will have access to the exam materials for a designated 24-hour period that begins at the exam's current date/time and will have the entire 24-hour period to prepare and submit their answer.
4	<b>Extended Take-home:</b> Students will be given access to the exam materials at the beginning of the exam period and may submit their answer any time during the exam period. Exam materials will be available beginning November 30 at 9 a.m. All exam answers must be submitted by December 11 at 4:30 p.m., regardless of when the student first accessed the exam materials.
