#### **FOOTNOTES**

Orientations for each of the offered Clinics will be scheduled for the first three-to-four weeks of the semester according to a schedule to be determined by the Director of each Clinic after conferring with enrolled students. The Clinic orientation schedule will be communicated to enrolled students in advance of the semester's start.

<sup>2</sup>In addition to the weekly class session, Mediation Clinic students must commit to participate in mandatory, full-day orientation sessions to be scheduled on the first two Saturdays of the spring semester. Each Mediation Clinic student will be required to pay a fee of \$100 to cover costs related to the Rule 31 training offered as part of the course curriculum. The Tennessee Alternative Dispute Resolution Commission also charges at the time of application an additional fee of \$100.

<sup>3</sup> Students who have prevously taken a fall or spring Clinic course are eligible to enroll as an Advanced Clinic student in that same clinic. If students have questions, please see the Professor who directs and teaches the base Clinic course.

<sup>4</sup>Courses require a permit.
