Thursday, December 5, 2024	<p>eBills available online on <a href="#">TigerXpress</a></p> <p>Students will be notified by email (U of M email address) when eBills are available and by text messaging if signed up on TigerXpress to receive text messages. Official Notifications and viewing eBills available online on <a href="#">TigerXpress</a>.</p> <p>Installment Payment Plan (IPP) available to sign-up on <a href="#">TigerXpress</a>. An initial down payment of 25% of the remaining balance of tuition and fees is required and the \$25 non-refundable enrollment fee will automatically be calculated in the total IPP plan amount. Beginning on January 1, 2025, the non-refundable enrollment fee will be \$50.00.</p>

Thursday, January 2, 2025	<p><b>Deadline to sign up for direct deposit on TigerXpress for processing excess financial aid/scholarship refunds as available for the initial direct deposit.</b></p> <p>NOTE: Students who miss this deadline should still sign up in preparation for subsequent disbursements.</p>
Monday, January 3	Refunds due from excessive financial aid funds will begin processing for the Spring 2025 term for all students signed up for direct deposit.
Tuesday, January 7	<b>Initial Fee Payment Deadline (4:30 p.m.) for all registered students.</b>
Wednesday, January 8	<p><b>First day of classes</b></p> <p><b>\$200 Late Fee begins for students enrolling in Full Term. Fee will be assessed to all students not paid-in-full or enrolled in the IPP. Late Fee also applies to any initial registrations.</b></p>
Wednesday, January 15	<b>Holiday: MLK Birthday</b>
Friday, January 17	<b>Last day for 100% fee adjustment/refund</b>
