NOTES

1. If you are unable to sit for the scheduled final exam, you may not enroll in the course.
2. A student enrolled in 6 or more credit hours may work no more than 20 hours outside the law school.
3. To be eligible for financial aid, law students must be enrolled in at least 3 law credit hours during the summer semester.
4. A student may not be enrolled in more than 9 credit hours during the summer semester.
5. Externships: Students must have successfully completed 28 credit hours to be eligible to enroll. Students will apply for and be accepted into an Externship for 2 credits (16 hours weekly), 3 credits (24 hours weekly), or 4 credits (32 hours weekly*), in addition to participating in a once-weekly seminar that will meet on Tuesdays from 4:00 p.m. to 5:30 p.m. The number of credit hours assigned to each Externship field placement is predetermined by Professor D. Schaffzin in consultation with the field placement supervisor. Credit is awarded for successful completion of both the field placement and the Externship Course seminar. Completion of the Externship Course will satisfy the Experiential Learning graduation requirement so long as a grade of Satisfactory or better is earned for the course. See Academic Regulation 16.1.C.2. An Externship may satisfy the Experiential Learning Requirement. *During the Summer Session, students enrolled in a 4-credit (32 weekly hours) externship may not concurrently enroll in any additional summer courses.
6. Family Law: A hybrid course with two synchronous class meetings each week (i.e., real-time classes by video) and weekly asynchronous activities (events happening at different times for each student). The synchronous class meetings will be Tuesdays and Thursdays from 1:30 to 3:00 p.m. For the asynchronous component of the class, your professor will assign a variety of assignments for each week. You may complete the weekly assignments at your own pace over the course of the week, as long as you submit them by the due date. Assignments may include pre-recorded videos, quizzes, readings, online discussion boards, virtual meetings with the professor, etc. Additional information will be provided in the course syllabus.
