<p><b>Monday, April 20</b></p>	<p><b>eBills available online on <a href="#">TigerXpress</a></b></p> <p>Students will be notified by email (U of M email address) when eBills are available and by text messaging if signed up on TigerXpress to receive text messages.</p>
<p><b>Monday, May 4</b></p>	<p>Deadline to sign up for eRefunds (direct deposit) on TigerXpress for processing excess financial aid/scholarship refunds as available for the initial direct deposit.</p> <p><b>NOTE:</b> Students who miss this deadline should still sign up in preparation for subsequent disbursements.</p>
<p><b>Tuesday, May 12</b></p>	<p><b>Financial Aid Disbursement for Summer-eRefunds (direct deposit) will begin to post to students' bank accounts.</b></p>
<p><b>Friday, May 15</b></p>	<p><b>Fee Payment Deadline (4:30 p.m.)</b> for students who register through May 15, 2020.</p> <p><b>Courses will be DELETED if not paid in full.</b></p> <p>TigerXpress will be unavailable after 4:30 p.m.</p> <p><b>Students who wish to re-register for courses with remaining seat availability may do so during *Late Registration and will be assessed a \$100 Late Registration Fee.</b></p>
<p><b>*Saturday, May 16 – Tuesday, May 19</b></p>	<p>Late registration and late add period  <i>(\$100 Late Registration Fee assessed during Late Registration)</i></p>
<p><b>Sunday, May 17</b></p>	<p>Last day for 100% fee adjustment/refund deadline</p>

*\*Students who receive permission to register after Late Registration from the Dean of their major must prepay all fees in full, including the assessment of a \$100 Late Registration Fee and a \$100 Late Payment Fee prior to being registered.*

<b>Tuesday, May 19</b>	Fee Payment Deadline for Late Registration (4:30 p.m.) to avoid the assessment of a \$100 Late Payment Fee.
<b>Friday, May 22</b>	<b>Fee Payment Deadline for Late Registration (4:30 p.m.) to avoid DELETION of classes.</b>  Courses DELETED IF NOT PAID IN FULL.  TigerXpress will be unavailable after 4:30 p.m.
<b>Monday, May 18 – Sunday, May 24</b>	75% fee adjustment/refund period
<b>Monday, May 25 – Sunday, May 31</b>	25% fee adjustment/refund period
<b>Monday, May 25</b>	Holiday – Memorial Day
<b>Friday, May 29</b>	Last day to drop a class without showing “W” on transcript
<b>Wednesday, June 3</b>	Last day to drop a class withdraw without permission
<b>Friday, June 5</b>	Last day to apply for August 2020 graduation
<b>Friday, July 3</b>	Holiday – Independence Day holiday observed
<b>Tuesday, July 7</b>	Last day of classes / <b>FRIDAY Class Schedule</b>
<b>Thursday, July 9 – Monday, July 13</b>	Exams
