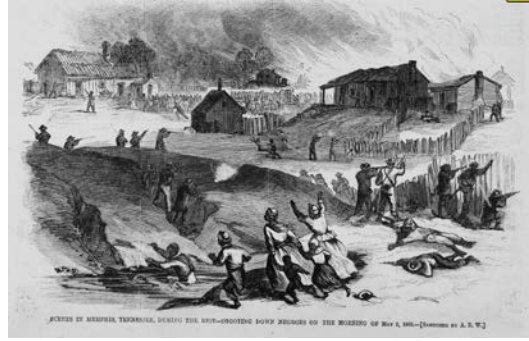


# Memories of a Massacre: Memphis in 1866

**Ongoing exhibit:** [Benjamin L. Hooks Central Library](#): "[Free at Last](#)," an exhibit made available by the Tennessee Civil War National Heritage Area. "Free at Last" explores black Tennesseans' efforts to give meaning to freedom in the aftermath of the Civil War. This exhibit is free and open to the public. In early May, it will be relocated to the Orange Mound Gallery at the Lamar-Airway Shopping Center, 2232 Lamar Ave., where it will also be free and open to the public. **May 1:** The Memphis Theological Seminary and Freedom's Chapel Christian Church: "[Voices from the Memphis Massacre](#)," a performance to commemorate the victims and survivors of the 1866 Memphis Massacre. **May 1:** Memphis NAACP: The Memphis NAACP will dedicate the historical marker honoring the victims of the 1866 Memphis Massacre. The dedication service will be held at 3:00 pm at the National Civil Rights Museum and will be followed by a march to Army-Navy Park (2nd & G.E. Patterson) where the marker will be unveiled. **May 20-21:** The University of Memphis will host "Memories of a Massacre: Memphis in 1866: A Symposium Exploring Slavery, Emancipation, and Reconstruction." The culmination of a semester-long series of lectures, workshops, discussions, and book talks, this symposium will feature historians and scholars from across the country, including Robert K. Sutton, Chief Historian of the National Park Service. Together, their presentations and the ensuing discussions will pry open what has for 150 years been the carefully concealed history of Reconstruction, its legacies, and the significant role Memphis played in both. Please join us as we reflect together on a wave a terror that rocked a city and changed a nation.
