- I have completed a Veterans' *Request for Certification* form.

- I have applied and been admitted to the University of Memphis (UofM) as a degree-seeking student.
- As required, I am submitting a copy of my Certificate of Eligibility with this application.
- Submitting this form does not guarantee my admittance to the Yellow Ribbon Program.
- If I am required to reapply for admission to UofM for any reason, UofM will not continue to hold my spot in the Yellow Ribbon Program; UofM is not required to continue making Yellow Ribbon Program contributions if I am not in good academic standing.
- I certify that the information I submit on this form is true and correct to the best of my knowledge.

You must contact the Veterans Educational Benefits & Certification Coordinator/VA Certifying Official if you add, drop, stop attending, or withdraw from courses after your initial registration. Adding, dropping, withdrawing, not attending, or stopping attendance may cause adjustments to your benefits and affect your student account.

There is a potential for a large overpayment to be charged to you. Students receiving Chapter 33, Yellow Ribbon, and any other monies designated for the sole purpose of paying tuition and fees may incur liability to repay monies as appropriate. If you drop, are reported as stopped attending, or withdraw from courses on or after the first day of classes, the school's refund policy will apply in the case of both money due and refunds. VA will seek any overpayment from you, not the school. As indicated on your Certificate of Eligibility, "You are responsible for ALL debts resulting from reductions or terminations of your enrollment even if the payment was submitted directly to the school on your behalf."
