Poverty by Age in Lebanon County

Analyzing poverty in Lebanon County according to age group, the highest rate of poverty is among children (under the age of 18) at 12.9%, while the lowest poverty rate is among seniors (individuals over the age of 65) at 4.5%. The poverty rate for the age group of 18-64 is 9.4%. When compared to the United States, the poverty rates for each age group are lower in Lebanon, Pennsylvania than in the United States.




Figure 1-Lebanon and U.S. Poverty by Age

In the state of Pennsylvania, the poverty rate for children (under the age of 18) is 18.5% which is higher than the poverty rate for children in Lebanon County (12.9%). For the age group of 18 to 64, the poverty rate in Pennsylvania is 12.3% and in Lebanon County, the poverty rate for this age group is 9.4%. For seniors (over the age of 65), the poverty rate is 7.8% in the state of Pennsylvania, and in Lebanon County, the poverty rate for seniors is 4.5%.




Figure 2-Lebanon County and Pennsylvania Poverty by Age

Lebanon County Poverty by Race

In Lebanon County, the highest rate of poverty is among Hispanic people at 22.1%. White people have the lowest rate of poverty in Lebanon County at 8.2%. Data for other racial groups are not found for Lebanon County. Compared to the U.S., the poverty rate for Hispanic people is higher in Lebanon County than in the U.S.






Figure 3-Lebanon County and U.S. Poverty by Race

In the state of Pennsylvania, the highest rate of poverty is among Hispanic people with a poverty rate of 30%. White people having the lowest rate of poverty in Pennsylvania (10.1%). The poverty rates for all available races are lower in Lebanon County than in the state of Pennsylvania as a whole.





Median Income in Lebanon County

The median total household income for Lebanon County is \$57,248 which is approximately the same as the median total household income for the U.S. (\$57,617). For families, the median income for Lebanon County is \$67,379, which is lower than the median income for families in the U.S. (\$71,062). For nonfamily households, the median income for Lebanon County is \$33,221 which is slightly lower than the median nonfamily household income for the U.S. (\$34,693).




Figure 5-Median Income in Lebanon County and U.S.

Yearly Overall Rates of Poverty

The poverty rate in 2016 for the U.S. is at 14%, which is a slight decrease from the poverty rate of 15.5% in 2015. The poverty rate in Lebanon County in 2016 is at 9%, which is also a decrease from the 13% poverty rate for Lebanon County in 2015.




Figure 6-Overall Poverty Rates for Lebanon and U.S. in 2016 and 2015
