### President Busby called the meeting to order

### Approval of March 2014 Minutes

### **Guest Speakers**

- Sarah Adair and Gayle Williams from the Tennessee State Employee Association (TSEA)
  - Ms. Adair addressed the Senate first and introduced herself as the Government Affairs Director for TSEA and stated that she lobbies for state employees on Capitol Hill. She offered her contact information as (615) 419-8955 and sarah.adair@tseaonline.org.
  - Ms. Adair indicated that she previously worked for the University of Memphis, with Kevin Roper, to find federal funding for research projects on campus, and has partnered with other schools within this state and other states to get support within Washington D.C. She left the University of Memphis to work at TSEA. She has been an employee of the State of Tennessee since 1998, states she is dedicated, and passionate toward state employees.
  - Ms. Adair said that revenue projections are still down for next year and she is worried that benefits, such as longevity and 90 vs. 30-day RIF notices, could be taken away if we don't continue to fight for them.

- The TSEA is involved with the "living wage" campaign. Ms. Adair explained her view on the situation by using the following example: If the federal minimum wage goes up to \$10.50/hr those being paid on a federal grant must receive \$10.50/hr and would leave a gap between the lowest paid employee's on campus.
- Ms. Adair spoke about what she was lobbying for right now. She said there was a workplace health amendment on the State Senate floor today that involves bullying in the workplace, work sabotage, intimidation, and humiliation. Other bills the TSEA is currently following regard no picketing and/or protesting, and no retaliation after whistleblowing.
- The Staff Senate floor was opened for questions.
  - Senator Ann Hudson asked how much the monthly dues were. And Ms. Adair responded - \$14.77/month. The dues include grievance process, rights during RIF's, problems with payroll, life insurance, cancer insurance, pet insurance, discounts on movies, etc..., and supplemental dental insurance.
  - Senator Brigitte Boyd asked if the insurance premiums were included in the monthly dues. Ms. Adair stated that no, insurance, etc. are additional premiums.
  - Senator Ann Hudson said, "TSEA was responsible for bringing the Sick Leave Bank to the UofM".
  - Ms. Adair responded by saying that it is understood that paid annual and sick days, and the pension program were brought to higher education because of TSEA.
  - Senator Vickie Peters asked what percent of employees belong to the TSEA? Ms. Adair's response was that about 1/3 of all State employees are members of the TSEA. She went on to say that retirees can continue their membership, dues are \$3/month, and all benefits can be kept.
- Ms. Gayle Williams from TSEA described the contents of an informational packet each Senator had received as they entered the meeting this morning.

### **New Business**

- Discussion of Staff Appreciation Day
  - The winning design for the 2014 Staff Appreciation Day announcement was revealed. It is a full color, blue and gray, design featuring a coffee cup in the middle giving a strong emphasis on the departure from the usual lunch-time event. Executive Committee members were reminded to attend the remaining planning meetings on Tuesdays in the Administration Building, Room 191.
  - The Lambuth campus will be having a Staff Appreciation luncheon on Friday, May 16, 2014. They are currently in the process of getting door

prizes for their event. Their luncheon will be from 11:30 a.m. until 1:00 pm in the Bistro, located in the Student Union Building. Senators are welcome to attend, however our Senate budget is unable to provide transportation/travel reimbursement.

- President Busby reminds all senators to actively seek and solicit items to give away for staff appreciation day.
