Colleagues,

As this semester nears its close, I am thankful for you and the opportunity to support such outstanding faculty. I have enjoyed my first 10 months in this job and look forward to a time when we are back on campus together.

You will find that this Grant Bulletin looks different from past issues. Instead of grant opportunities, I am presenting you with a “watch list.” Many federal opportunities have not yet been posted for this year. There are a couple of reasons: 1) The federal government does not have an approved budget—they are operating on continuing resolutions. This has caused a delay in the release of many grant programs. 2) The upcoming change in administrations in the federal government has likely also caused the delay in some programs, and staff may be focusing on other priorities rather than grant competitions.

I urge you take a few moments to review this list. If there is a program that fits your interests let me know and I will follow up with you when the RFP is released. For some competitions that are reliably held every year, you might want to go ahead and start working on that application - especially if it involves community partners (as most SUAPP grants do). If there are other opportunities that are not on this list that you would like me to watch out for, send me the program name and I will add it to my “watch list”.

I will be working most of December and January before the semester starts. I look for you to keep me busy—let’s meet and strategize ways to approach that federal grant application this time around.
