BS Nursing

3 Program revision proposals in Curriculog were used to identify significant revision to the **one** program (at the undergraduate level there is only one major in the BS, which is Nursing. Curriculum changes were proposed to reflect existing practice, which is that three **pathways** to the BS Nursing exist but these have not been evident or described clearly in our UG catalog. However, actual curriculum revisions are proposed to meet changing nursing education standards of the TN Board of Nursing as well as the Commission on Collegiate Nursing Education.

(To all three existing pathways--1) Traditional – BSN -students entering as freshmen; 2) RN-BSN—students who are licensed RNs but do not have their BS degree; and 3) students who already have an undergraduate degree but do not have their nursing coursework toward licensure.
