I. Call to Order – Carol Danehower, Chair

III. New Business-- College of Education

Sandra Cooley-Nichols, Chair of the Department of ICL, presented curriculum changes (details in attached PPT slides) proposed for the B.S.Ed (Human Development and Learning major and the Teaching All Learners major) that are necessary to retain licensure with the TN Department of Education.

UUC members will be notified when these proposals are available in Curriculog for review. These new courses, course revisions, and program revisions will also need to be *voted on in Curriculog* by UUC no later than March 1, as the institutionally approved programs are due to the State by March 6.

The revisions must be "in place" no later than 2026, but we may implement them here at UofM as early as Fall 2024. Any changes requested by the state and any fine-tuning of details, including wording of course descriptions, may be proposed in the next curriculum cycle –Fall 2023 (so the UUC may see these proposals again next year) for Fall 2024 implementation.

<u>Update from Carol</u> – THEC is revising processes as well as hiring new staff and realigning staff responsibilities. Carol will provide more detail on implications as they are known. At this point possible options are the Transfer Policy Working Group report and CIP code change process; also strategic plan implications for UG curriculum; others??? 


