A NOTE ON OUR METHODOLOGY: Spanish 1010, 1020, 2010 and 2020 are taught in a **blended format**, that is, we will use a combination of face-to-face and computer-mediated instruction. Also, we will use a model called the "**flipped classroom**"; in a flipped classroom, students work on the material before coming to class and class time is used to practice the material learned at home. Additionally, our **target language policy** expects both teachers and students to use 80% Spanish in 1010 /1020 and 90% Spanish in 2010/2020.

What does this mean for you? This means that: (i) you are required to complete your online assignments on your own and spend a significant amount of time each week doing so; (ii) you have to come to class prepared to practice what you studied at home (Do NOT expect your teacher to go over grammar and vocabulary in class; instead your teacher will help you use/practice the assigned grammar and vocabulary in context through written or oral communicative activities; (iii) you need to use Spanish to communicate with your teacher and classmates during the semester.

Understanding and following this methodology is key to your success in this course.

Class Participation (PAC):

Homework

There are four types of homework in SPAN 2020: Guided Comprehension Activities, VHL Supersite (Preparation Activities) VHL Supersite (Review Activities), other individual assignments from your instructor.

- Guided Comprehension Activities- Guided Comprehension Activities (GCAs) are structured to help you better understand assigned readings (*lecturas*) and videos (*videos culturales y cinemateca*). Students are required to print, complete, and bring the GCAs (Antes de clase) to class on the day the material is scheduled to be covered on the Course Calendar. Your instructor will check for completion at the beginning of class. You will only receive credit for the GCA if it is complete at the time that your instructor checks it. Late work will NOT be accepted except with an approved Missed Assessment Approval Form. By completing the GCAs before class, students will be prepared for the in-class activities relevant to the readings or videos.
- VHL Supersite (Preparation) VHL Supersite activities classified as "preparation" are assigned to
 prepare the student for grammar quizzes and in-class activities. They must be completed by the due
 date as listed on VHL Supersite. Any VHL Supersite Preparation activities completed after the due
 date/time will not receive any credit.
- VHL Supersite (Review) / Instructor Assignments VHL Supersite activities classified as "review" are
 assigned to reinforce the student's understanding of grammatical concepts and content covered in the
 reading. They must be completed by the due date as listed on VHL Supersite. Any VHL Supersite
 Review activities completed after the due date/time will receive 50% credit.

Syllabus Quiz You will need to complete the Syllabus Quiz on eCourseware before the third week of classes. The objective of this quiz is to ensure that you have read the syllabus and that you are aware of important deadlines, class policies etc.

3 Exams

The unit evaluations are summative assessments that focus on **listening**, **reading**, **grammar**, **and writing** in relation to topics studied as part of the unit material. Assessment of second language learning is always cumulative. The assessment schedule will be as follows: Unit 1-Present Indicative, Unit 2-Present Subjunctive, and Unit 3-Preterite and Imperfect. Therefore, the assessments will presume that the student can demonstrate competence of all vocabulary and grammar covered in SPAN 1010, 1020, and 2010.

Presentations: Students will work in pairs on two presentations (one in-class) and one video.

Final Interview

Students will be assigned a partner for this assessment. Students will interview each other in front of the instructor during the final exam period (See official UofM <u>final exam schedule</u>). Topics of the conversation will be based on content covered in SPAN 2020.

CLASS POLICIES

Attendance and Tardiness Policy

Daily attendance is compulsory and expected (including the first day of class). Attendance will be taken, and each student will be allowed 6 absences for classes that meet three days a week (MWF) and 4 absences for classes that meet 2 days a week (MW, TTH). If a student exceeds these allotted absences, there will be a reduction of the student's grade. Every 3 times you come late to class counts as 1 absence. NO EXCEPTIONS WILL BE MADE TO THIS RULE UNLESS EXTREME EXTENUATING CIRCUMSTANCES APPLY. Complete the Missed Assessment Approval Form to validate circumstances.

Missed Assessment Approval

If an emergency prevents you from taking an assessment, you <u>must</u> complete the <u>MISSED ASSESSMENT</u> APPROVAL FORM with valid <u>written documentation</u> to justify your absence including <u>all</u> required information. Examples of valid written documentation include: an official doctor's note, an official court citation, a published funeral notice, or an official police report. These documents must state clearly that you were unable to attend class the day of the assessment. Non-acceptable documentation includes: attendance to a wedding or other social event, travel arrangements, employer-related requirements, a drug prescription, a routine doctor's appointment. If you miss an assessment without completing the MISSED ASSESSMENT APPROVAL FORM (including valid written documentation) to justify your absence, then you will receive a 0 for the missed assessment. Be sure that your schedule does not conflict with your course exams!

Excused Absences for University Extracurricular Activities: Students participating in an officially sanctioned, scheduled University extracurricular activity will be given the opportunity to make up class assignments or other graded assignments missed as a result of their participation. It is the responsibility of the student complete the MISSED ASSESSMENT APPROVAL FORM with valid <u>written documentation</u> to justify your absence including <u>all</u> required information —prior to the absence—in order to make up missed assignments.

Extra Credit Policy

Students can complete only **ONE** activity per semester that will count as extra credit. Students will be required to provide proof of participation. The extra credit points will be added to your overall "Exams" grade. Specific guidelines are posted on eCourseware. There is a series of activities that have been approved for extra credit:

- SPAN 2020 Cultural Questionnaire is an activity that your instructor will provide with more details.
- La Mesa Española that is an informal gathering that meets one hour weekly and functions as an informal time to practice speaking Spanish. You must attend the table twice to earn the credit, once <u>before</u> Fall/Spring Break and once after Fall/Spring Break.
- The Spanish Club that offers several cultural events per month that include attending a church service conducted in Spanish, salsa dancing, and even enjoying authentic Hispanic restaurants. Charges may apply for some events. Schedules for these organizations will be given as at the appropriate time. Your instructor will provide more details.
- The Hispanic Film Festival in which we play original films in Spanish with English subtitles. It takes place every **Fall**.
- The Language Fair that is a competition among high school students. It takes place every **Spring**.

<u>Do Not ask your instructor for any other extra credit opportunities</u>. These are the only activities approved for Spanish 1010, 1020, 2010 and 2020. <u>Do Not ask your instructor to add it to any other assignment</u>.
