COURSE DESCRIPTION

The course, SPAN 3301 Conversation, takes a realistic, thematic approach to improving conversational Spanish. It is presented in 12 modules that include weekly conversational topics as well as short films to highlight contemporary elements of Hispanic culture. A strong emphasis is placed on cultural comparison and contrast so the student can relate the material to their own experience. This course is based on the understanding that language acquisition takes place through active use of the language. **Not intended for students with native or near-native proficiency.** Prerequisite and corequisite: SPAN 2020 or permission of the instructor.

SPECIAL NOTE: HYBRID FORMAT SPRING 2021

Hybrid Instruction combines face-to-face and online instruction into one cohesive learning experience. Face-to-face synchronous sessions, either on-ground or via Zoom, allow students to apply, practice and reinforce the material prepared and studied online asynchronously.

Due to circumstances related to COVID-19, this course is delivered in a hybrid instructional format to ensure an equitable, inclusive, and safe learning experience for all students, and therefore students may attend class on-ground or virtually via Zoom. Synchronous meetings will occur at the regularly scheduled times on Mondays and Wednesdays for conversation, discussion and application of material. On Fridays, students will complete asynchronous activities such as readings, quizzes, exams and online discussion via eCourseware according to the due dates listed in the course calendar.

COURSE OBJECTIVES

The overall goal of this course is to develop ACTFL (American Council of the Teaching of Foreign Languages) intermediate mid speaking and listening skills in Spanish while deepening the awareness and appreciation for Hispanic/Latinx culture. At the end of the course, students will be able to:

- ✓ Discuss various topics regarding Hispanic culture and history
- ✓ Attain an intermediate mid proficiency level when listening/speaking Spanish
- ✓ Analyze cultural practices and historical events from the Spanish-speaking world
- ✓ Build vocabulary through vocabulary activities and contextualized readings
- ✓ Use familiar and newly acquired vocabulary in daily conversation and communication
- ✓ Acquire cultural knowledge through short films, conversations with native speakers and class discussions
- ✓ Interact in role-play scenarios using level-appropriate vocabulary and grammatical structures

Participation & Attendance (20%)

Success in learning a world language is directly related to the amount of time the student spends in contact with the target language. Language learning is a cumulative process that requires daily attendance and active class participation; therefore, SPAN 3301 being a conversation course, attendance and active participation are crucial components to student success. Considering the varied circumstances as a result of COVID-19, our class will meet in a small group setting in person and/or online. As per University Policy, students are expected to be available during the days and times in the official schedule of the Registrar. If students are not able to attend class in person, they should attend the synchronous session remotely via Zoom or contact the instructor for alternative accommodations to make up the missed class. Expected class participation includes coming to class prepared, being attentive and actively engaged, volunteering often, answering and asking questions frequently, responding in class in complete sentences and demonstrating strong effort throughout the semester. Students are expected to actively contribute to class and group discussions always in Spanish. Failure to actively participate in class and/or frequent and disruptive use of English will result in a deduction of the student's participation grade.

Homework (10%)

Students will complete homework exercises according to the course calendar by the due dates indicated. Exercises include but are not limited to vocabulary building, grammar review, and reading and listening comprehension. Homework will be submitted in eCourseware.

Cortometrajes (6%)

Students will view and analyze six (6) short films over the course of the semester to practice listening comprehension, expand cultural knowledge and prepare for discussion both in class, in the online discussion board on Flipgrid and with LinguaMeeting native coaches. Written analyses will be submitted in eCourseware.

LinguaMeeting (6 sessions x 4% = 24%)

Students will purchase six (6) sessions of LinguaMeeting to practice their conversational skills with a language coach, native speaker of Spanish, for six 30-minute coaching sessions throughout the semester. Topics for the coaching sessions will align with the short films viewed for class. Session availability opens and closes for each session according to specific dates on the course calendar. Note all session dates that you choose, as they are your responsibility. Remember that LinguaMeeting is *not* a tutoring service, rather a program to help you develop oral proficiency so that you are able to speak Spanish with confidence.

Students are permitted *one* LinguaMeeting make-up session over the course of the semester, and it must be made up during the same availability window as the original session. After the session due date, the topic will change, so it is necessary to complete the make-up before the session due date. If a student schedules a make-up session after the session due date, they must prepare to discuss topics from both the missed session *and* the current session.

Flipgrid Discussions (10%)

Each week students will interact with classmates in the virtual discussion board platform, Flipgrid, on a variety of topics related to course content to further develop their oral proficiency in Spanish. Students will post one original video responding to discussion questions each week by Wednesday and follow-up with at least two (2) videos on classmates' posts with meaningful comments, questions, ideas and/or interactions Friday. Online discussions are not graded for accuracy, rather meaningful and thorough contribution to the weekly discussion.

Role-play Scenarios (15%)

Students will participate in partner role-play scenarios selected at random from the *Escenas* section of the text to showcase their speaking skills, one at midterm and one at the end of the semester. Role-play scenarios will be prepared and practiced in advance but will not be scripted to encourage spontaneity and natural conversation. Students will be evaluated individually on their ability to express themselves clearly, use level-appropriate vocabulary and grammatical structures and their efforts to pronounce the sounds of Spanish correctly.

Exams (15%)

Students will complete two exams, one midterm and one final (not cumulative) to demonstrate their comprehension of course material. Exercises will include listening and reading comprehension, vocabulary and grammar.

COURSE TOPICS

The course is divided into four units, each of which has three modules including cultural readings, key vocabulary with exercises, a grammar review and additional comprehension activities.
