COURSE DESCRIPTION

Designed for advanced intermediate students of Spanish, the goal of this beginner composition course is to put grammar into practice to develop high intermediate writing skills. Students learn to use the multi-step composition process to brainstorm and outline ideas *before* writing, compose a rough draft, and then revise and edit with the help of peers and tutors before publishing a final draft. Compositions are analyzed to identify and avoid frequent grammatical errors and to avoid interference from English. **Not intended for students with native or near-native proficiency.** Prerequisite and corequisite: SPAN 2020 or permission of the instructor.

SPECIAL NOTE: HYBRID FORMAT SPRING 2021

Hybrid Instruction combines face-to-face and online instruction into one cohesive learning experience. Face-to-face synchronous sessions, either on-ground or via Zoom, allow students to apply, practice and reinforce the material prepared and studied online asynchronously.

Due to circumstances related to COVID-19, this course is delivered in a hybrid instructional format to ensure an equitable, inclusive, and safe learning experience for all students, and therefore students may attend class on-ground or virtually via Zoom. Synchronous meetings will occur at the regularly scheduled times on Mondays and Wednesdays from 10:20-11:15am in small groups of no more than 8 students for conversation, discussion and application of material. On Fridays, students will complete asynchronous activities such as readings, quizzes, exams and writing assignments via eCourseware according to the due dates listed in the course calendar.

COURSE OBJECTIVES

The overall goal of this course is to develop writing skills by putting grammar into practice. By the end of the semester students will:

- ✓ Produce compositions based on the process approach to writing (brainstorm, outline, rough draft, revision and final draft).
- ✓ Critique peer compositions based on a demonstration of level-appropriate grammatical competency, vocabulary, and course content.
- ✓ Revise and publish five compositions including an autobiography, description, narration with dialogue and exposition.
- ✓ Discuss reading and listening selections about culture relevant to composition topics.
- ✓ Expand vocabulary, grammatical competency, and cultural competency via selected course reading and listening selections.

Participation & Attendance (10%)

Success in learning a world language is directly related to the amount of time the student spends in contact with the target language. Language learning is a cumulative process that requires daily attendance and active class participation; therefore, attendance and active participation are crucial components to student success in SPAN 3303. Considering the varied circumstances as a result of COVID-19, our class will meet in a small group setting in person and/or online. As per University Policy, students are expected to be available during the days and times in the official schedule of the Registrar. If students are not able to attend class in person, they should attend the synchronous session remotely via Zoom or contact the instructor for alternative accommodations to make up the missed class. Expected class participation includes coming to class prepared, being attentive and actively engaged, volunteering often, answering and asking questions frequently, responding in class in complete sentences and demonstrating strong effort throughout the semester. Students are expected to actively contribute to class and group discussions always in Spanish. Failure to actively participate in class and/or frequent and disruptive use of English will result in a deduction of the student's participation grade.

Homework (7.5%)

Students will complete homework exercises according to the course calendar by the due dates indicated. Exercises from the textbook will be assigned for homework and completed in eCourseware. Homework will be turned in and evaluated in Dropbox.

Literature and Podcasts (7.5%)

Students will read selections from CommonLit and listen to podcast episodes which correspond to unit themes and complete follow-up assignments assessing their comprehension. CommonLit readings and assignments will be submitted and assessed in CommonLit, and podcast assignments will be submitted and assessed in eCourseware.

Grammar Quizzes ($5 \times 2\% = 10\%$)

Students will complete grammar quizzes covering topics from all five modules to assess their comprehension and application of course material. Quizzes will be assigned and assessed in eCourseware.

Compositions (5 x 12% = 60%)

Throughout the course of the semester, students will write five 300-375-word high quality (not quantity) compositions according to various topics: autobiography, description, narration, narration with dialogue and argumentation. All compositions will be composed, edited and revised using the 5 steps in the writing process: brainstorm, outline, rough draft, revision (peer review and tutor review) and final draft (*lluvia de ideas*, esquema, borrador, revisión y versión final). Each step is important and will be included in the evaluation of the overall writing assignment. Compositions I-IV will use the following weight distribution. For the fifth and final composition, students will be expected to apply all steps of the writing process **on their own** and collaborate with peers and tutors to turn in a polished final draft worth the entire 12%. Detailed composition rubrics are available on eCourseware. Each component of the writing process will be uploaded to Dropbox.

Compositions I-IV $(4 \times 12\% = 60\%)$

- Brainstorm 1%
- Outline 1%
- Rough draft 4%
- Peer review 2%
- Tutor review 1%
- Final draft 3%

Using online translators for entire sentences or paragraphs is **strictly prohibited** and violates the <u>Code of Student Rights and Responsibilities</u> (see section on Academic Integrity). A composition that shows advanced structures that we have not seen in the course or evidence of use of a translation device or external help from a friend, family member, etc. will receive a lower score since this will reflect at least one of the following (a) the student has used an online translator, (b) the student has plagiarized the composition, or (c) the student has not written his/her own composition. You are only permitted to use a good online dictionary such as <u>Word Reference</u> to find words that you do not know. The written assignments must demonstrate material covered during the semester (grammar, vocabulary, etc.) according to composition instructions.

Final Presentation

To conclude the semester, students will translate their writing skills to presentational format by creatively designing a final presentation. Students will use attractive visuals and images to enhance the ideas communicated in the presentation. More guidelines and a rubric will be provided toward the end of the semester. The presentation will be turned in to Dropbox.

COURSE TOPICS

✓ **Module 1: Autobiography** Students work through the preliminary chapter of the text to produce, revise, edit and publish an original autobiographical sketch using simple sentences.

- ✓ **Module 2: Description** Students work through chapter one of the textbook to produce, revise, edit and publish an original descriptive composition about a person, object or place using simple and complex sentences.
- ✓ **Module 3: Narration** Students work through chapter two of the text to produce, revise, edit and publish an original narrative composition in the past tense about a place they have visited, an event, an activity, a holiday, a vacation or a celebration, or another experience in which they participated.
- ✓ Module 4: Narration with Dialogue Students work through chapter three of the text to produce, revise, edit and publish an original narrative composition including dialogue using subjunctive tense which highlights use of expressing wishes, influence and doubt.
- ✓ Module 5A-C: Argumentative Exposition Students work through chapter four of the text to produce, revise, edit and publish an original argumentative exposition using conditional sentences which reflect the student's ability to think critically and offer evidence about a certain topic.

GRADING SCALE

- ✓ A: Outstanding, excellent quality work earns an A, far exceeding what is expected (superior).
- ✓ **B:** Very good, high quality work earns a B, goes slightly beyond what is expected (above average).
- ✓ C: Competent, satisfactory work earns a C, meeting what is expected (average).
- ✓ **D:** Acceptable, adequate work earns a D, needs improvement to meet expectations (below average).
- ✓ **F:** Unacceptable, unsatisfactory work; demonstrates little if any effort and/or understanding (failing).
